PROPOSED TERMINATION OF ORDER No. R2-2018-0029 CEASE AND DESIST ORDER FOR THE CITY OF HERCULES, FOR VIOLATION OF TRASH REQUIREMENTS OF MUNICIPAL REGIONAL STORMWATER NPDES PERMIT R2-2015-0049

NOTICE IS HERBY GIVEN THAT the San Francisco Bay Regional Water Quality Control Board (Water Board) will accept written comments on the Tentative Order for termination of Order No. [R2-2018-0029](#), Cease and Desist Order for City of Hercules (City).

The Tentative Order would terminate the Cease and Desist Order, issued to the City for violation of trash control requirements of Municipal Regional Stormwater NPDES Permit (Order No. R2-2015-0049). The City has met the Cease and Desist Order's requirements by reducing trash loads by 80 percent.
