### **NOTICE OF CANCELATION OF HEARING**

The State Water Resources Control Board

had noticed for April 8, 2022 a Public Hearing on the

#### **Statement of Water Diversion and Use S011135 of Clinton and Jane Kelley (“Respondents”)**

#### **TO ALL PARTIES:**

The Administrative Hearings Office (AHO) of the State Water Resources Control Board (State Water Board) received on January 3, 2022, a hearing request in this matter, postmarked November 15, 2021. The AHO issued a Notice of Hearing on January 27, 2022. Later that day, the AHO received an e-mail from Jane Kelley of the “Clinton E. Jr. and Jane K Kelley Family Trust.” Ms. Kelley is a Respondent in this matter. The e-mail stated that the Kelleys wish to withdraw their hearing request. The Kelleys’ e-mail to the AHO copied Debi Ores and Matthew Quint of the State Water Board’s Office of Enforcement. On Friday, January 28, Mr. Quint forwarded Ms. Kelley’s January 27, 2022 e-mail to the AHO inbox. Both e-mails have been saved on the State Water Board’s FTP site for this matter.

Because the Respondents have withdrawn their hearing request, the AHO proceeds as though the Kelleys had never requested a hearing. Therefore, the parties may choose to proceed according to any settlement agreement they may have, or according to the terms provided in the draft Administrative Civil Liability Complaint, or according to other directions from the Division of Water Rights Office of Enforcement staff.

Based on this message from the Respondent, the AHO cancels the hearing in this matter that was scheduled for April 8, 2022 at 9:00 am.
