NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT AND NOTICE OF PUBLIC WORKSHOP ON WORKING DRAFT SCIENTIFIC BASIS REPORT FOR POTENTIAL AMENDMENTS TO THE WATER QUALITY CONTROL PLAN FOR THE SAN FRANCISCO BAY/SACRAMENTO- SAN JOAQUIN DELTA ESTUARY PHASE II UPDATE

NOTICE IS HEREBY GIVEN that the State Water Resources Control Board (State Water Board) will accept written comments on the Working Draft Scientific Basis Report on the Phase II update of the 2006 Water Quality Control Plan for the San Francisco Bay/Sacramento-San Joaquin Delta Estuary (2006 Bay-Delta Plan). The State Water Board will also provide an opportunity for the public to present oral comments at a public workshop. This will be an informational workshop only and the State Water Board will take no formal action.

BACKGROUND

The State Water Board is reviewing and updating the 2006 Bay-Delta Plan to ensure that Bay-Delta beneficial uses are reasonably protected. The Phase II update is focused on potential changes to requirements to reasonably protect fish and wildlife, with consideration of other beneficial uses including: municipal, industrial, agricultural, power production, and other environmental uses. Phase II addresses potential: new inflow requirements for the Sacramento River, its tributaries, and eastside tributaries to the Delta; changes to Delta outflow requirements; new and modified interior Delta flow requirements; and new cold water habitat protection requirements. Phase I is a separate process considering updates to flow requirements on the Lower San Joaquin River and salinity objectives for the Southern Delta.

A comprehensive regulatory approach is needed to protect Bay-Delta fish and wildlife throughout their migratory range with an integrated framework for inflows, outflows, and interior Delta flows that provides for timely action, flexibility, and coordination with other planning, regulatory, and restoration efforts. This includes the integration of needed flow and nonflow actions to the extent possible, and science, monitoring, and evaluation activities. New requirements would include adaptive management provisions to respond to new and changing information over the long term and in real time.

A working draft Scientific Basis Report (Report) is being prepared to support the Phase II update of the Bay-Delta Plan. The Report identifies the science that will be relied upon to consider potential changes to the Bay-Delta Plan in Phase II. Under Public Health and Safety Code section 57004, the State Water Board is required to have the scientific basis for potential changes to the Bay-Delta Plan undergo external peer review. The Report is being released as a working draft in order to receive early additional scientific input from other agencies, including the Delta Independent Science Board (ISB), and the public prior to submittal of the Report for external peer review. Based on the comments received on the working draft, the State Water Board will update the Report that will be submitted for external peer review.

In addition to the draft Report, the State Water Board has developed the Sacramento Water Allocation Model (SacWAM), which is a hydrology and system operations model to help evaluate various potential environmental and economic impacts associated with Phase II alternative regulatory requirements. The Delta Science Program (DSP) is conducting an independent science review of SacWAM, and is planning to hold a review panel workshop on Wednesday, October 19, 2016. Once reviewed and refined, the State Water Board expects to use SacWAM to inform future analyses included in the final version of the Report as appropriate.

PURPOSE OF THE WORKSHOP

The purpose of this workshop is for the State Water Board to receive comments and other technical information related to its draft Report on the scientific basis for Phase II updates to the Bay-Delta Plan. At the workshop the Board will receive recommendations from the public and other agencies regarding any additional scientific information that should be considered during development of the final draft Report. This is a technical workshop in which the State Water Board is interested in receiving scientific input only. Phase II is in its early stages and there will be additional opportunities for public participation and comment as the planning process moves forward.
