Pursuant to our January 24, 2013, letter "Protocol to Provide Earlier Notification to the State Water Resources Control Board and Partner Fisheries Agencies", this email serves as notification that the 14-day running average EC value at San Joaquin River at Jersey Point exceeded .74 mmhos/cm on Sunday, July 17, 2016. The 14-day average value reached .75 mmhos/cm on that day.
