The hearings and submission of exhibits and testimony have been **INDEFINITELY POSTPONED**. Further notification will be provided when the hearings are rescheduled.



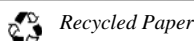
