On June 23, 2023, the Central Coast Regional Water Quality Control Board (Central Coast Water Board) submitted a letter requesting an extension of time for filing written comments until July 28, 2023. On June 27, 2023, California Coastkeeper Alliance, et al. (CCKA Petitioners) submitted a letter (1) requesting an extension of time for filing written comments until August 14, 2023, (2) requesting that the State Water Board convert the August 15, 2023 public meeting to a workshop, with consideration of adoption deferred to a later public meeting, and (3) requesting live Spanish language interpretation during all public meetings on this item. On June 28, 2023, the Grower-Shipper Association of Central California, et al. (GSA Petitioners) submitted a letter opposing CCKA Petitioners' extension request, but not opposing the Central Coast Water Board's extension request.

The State Water Board hereby (1) grants all interested persons an extension of time, until **12:00 noon on Friday, August 11, 2023**, to submit written comment on the proposed order, and (2) provides notice that the State Water Board has rescheduled the public meeting to receive oral comments and consider adoption of the proposed order from August 15, 2023 to **Tuesday, September 19, 2023, at 9:30 a.m.** The State Water Board will arrange for live Spanish language interpretation during this meeting.
