In accordance with the requirements for excluding agricultural water use from the DRINC urban water supply calculation, Camrosa is pleased to submit our supporting documentation. References made herein are to Agricultural Water Use Exclusion – REQUIREMENTS (found as “ag_exc_reqs_form.pdf” on the DRINC Portal).

In addition to reporting the total quantity of potable water supplied for commercial agricultural use as part of our monthly conservation reporting to the State Board through the DRINC portal (requirement 1), please see the attached Agricultural Water Use Exclusion – CERTIFICATION, signed by Camrosa General Manager Tony Stafford (2), and the list of each customer (reported as account number) that receives potable water deliveries for commercial agriculture use (3).

Camrosa will prepare and submit an Agriculture Water Management Plan to the Department of Water Resources by February 13, 2015 (4).

The Camrosa Water District Board of Directors has determined, having taken into consideration Camrosa’s conservation tier (Tier 8 requiring a 32-percent cutback), and in light of the 16.5-percent allocation reduction imposed on Camrosa by Metropolitan Water District and Calleguas Municipal Water District, that Commercial Ag water use shall be reduced by 16.5 percent (5).

I further certify that:

1. I will oversee, review, and take full responsibility for the completeness and accuracy of all data submitted to the State Water Resources Control Board as part of the reporting required pursuant to California Code of Regulations, title 23, section 865, subdivisions (b)(2) and (e);
2. **Camrosa Water District** will prepare and submit to the Department of Water Resources, no later than February 13, 2016, an Agricultural Water Management Plan that includes a detailed drought management plan describing the actions and measures the supplier will take to manage water demand during drought; and
3. **Camrosa Water District** will impose reductions on water it delivers to its commercial agricultural users, as determined locally appropriate by the supplier taking into consideration its applicable urban water supplier conservation standard (tier) under California Code of Regulations, title 23, section 865; and
4. I have the authority to make the aforesaid certifications on behalf of **Camrosa Water District**

I acknowledge that submitting any information pursuant to California Code of Regulations, title 23, section 865, subdivision (e)(1)(B) or (C), including this certification, that is found to be materially false by the State Water Resources Control Board is a violation of that section, punishable by civil liability of up to five hundred dollars (\$500) for each day in which the violation occurs. Every day that the error goes uncorrected constitutes a separate violation. Civil liability for the violation is in addition to, and does not supersede or limit, any other remedies, civil or criminal.
