TO ALL PARTIES:

The State Water Resources Control Board (“State Water Board”), Administrative Hearings Office (“AHO”), issued a Notice of Public Hearing in this matter on August 17, 2020. This notice scheduled a hearing on the amended Draft Cease and Desist Order that the Delta Watermaster issued on June 12, 2020, to the George Speckman Testamentary Trust (“Respondent”).

On October 27, 2020, the AHO received a copy of a settlement agreement signed by the Delta Watermaster and a representative of Respondent. This settlement agreement states that it resolves the hearing issues raised by the amended Draft Cease and Desist Order. On October 27, 2020, the Delta Watermaster submitted a proposed settlement order that would approve this settlement agreement.

Based on the receipt of these documents, the AHO cancels the hearing that was scheduled for November 3 and 4, 2020. The AHO will review the proposed settlement order and prepare a settlement order approving this settlement agreement and transmit that proposed order to the Board’s Executive Director for her consideration.
