**NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT AND  
NOTICE OF PUBLIC HEARING**

**NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) GENERAL  
PERMIT FOR STORM WATER DISCHARGES FROM  
SMALL MUNICIPAL SEPARATE STORM SEWER SYSTEMS (MS4s)  
REVISED DRAFT TENTATIVE ORDER**

**NOTICE IS HEREBY GIVEN THAT** the State Water Resources Control Board (State Water Board) will receive written comments on the Revised Draft NPDES General Permit for Storm Water Discharges from Small MS4s (Revised Draft Tentative Order).

**NOTICE IS ADDITIONALLY HEREBY GIVEN THAT** the State Water Board will hold a Public Hearing on the Revised Draft Tentative Order. A quorum of State Water Board members may be present at the public hearing; however, no Board action will be taken. The time and location of the public hearing is:

**BACKGROUND**

On December 8, 1999, U.S. EPA promulgated the Storm Water Phase II Final Rule under authority of the Clean Water Act (CWA) § 402(p)(6). The regulations require State Water Board to issue an NPDES permit for operators of Small MS4s. In 2003, the State Water Board adopted [Water Quality Order No. 2003-0005-DWQ](#), NPDES General Permit CAS000004, regulating storm water discharges from Small MS4s. If adopted by the State Water Board, the Revised Draft Tentative Order will supersede Water Quality Order No. 2003-005-DWQ upon its effective date.

A public notice was circulated on June 7, 2011, advising that a Draft Tentative Order was available for public review and comment. The June 7, 2011 notice established an August 8, 2011 deadline for submitting written comments. On July 27, 2011, the public was notified that the deadline for submitting written comments was extended to September 8, 2011. A public workshop on the Draft Tentative Order was held on August 17, 2011.

Based upon comments received during the public comment period and at the August 17, 2011 public workshop, the Draft Tentative Order has been substantially revised. The Revised Draft Tentative Order dated May 18, 2012 is the subject of this Notice.

The Revised Draft Tentative Order proposes to designate a number of listed entities as regulated under the permit. These lists may continue to be revised before adoption of the final Order. Further, entities not listed at the time of adoption of the final Order may nevertheless be regulated under the final Order by designation by a Regional Water Quality Control Board during the permit term. All Small MS4s are therefore on notice that they may be regulated under the Revised Draft Tentative Order, if adopted, and must submit any comments during the noticed public comment period regardless of whether they are currently listed as designated.

### **NATURE AND PURPOSE OF HEARING**

At the hearing, State Water Board staff will provide a brief overview of the Revised Draft Tentative Order and will answer any questions by the public. Interested parties will have an opportunity to address the Board. Participants may summarize their written submissions and make policy statements, but no new evidence will be admitted. The State Water Board may impose time limits on oral comments. There will be no sworn testimony.

### **FUTURE WORKSHOPS AND ADOPTION MEETING**

Staff will conduct informal workshops on the Revised Draft Tentative Order in June and July 2012. The dates and locations of the informal workshops are as follows:

Staff expects to submit the final Tentative Order to the State Water Board for consideration of adoption in October 2012.
