**PROPOSED UNDERGROUND STORAGE TANK CASE CLOSURE

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept comments on the proposed underground storage tank (UST) case closure for former Los Angeles Fire Department (LAFD) UST case number TT which was transferred to the State Water Board in July 2013.

Upon review of the case, the State Water Board may close or require the closure of any UST case if it is determined that corrective action has been completed in accordance with Health and Safety Code section 25296.10.

Pursuant to Health and Safety Code section 25296.10, the State Water Board will be considering, at a future board meeting, this UST case closure Order. You will separately receive an agenda for this meeting.

A copy of this notice has been provided to the responsible party, owner/operator, environmental consultant on record, the applicable Regional Water Quality Control Board and local agency that has been overseeing corrective action, agencies with authority to issue building permits, owners and occupants of the impacted property, owners and occupants of all parcels adjacent to impacted properties, the water replenishment district, the local water purveyor, the municipal water district, county water district, and special act district with groundwater management authority.
