### Discussion/Informational Items

11. Transformation and Recovery: Santa Rosa Channel Island, 20 Years after Issuance of Cleanup and Abatement Order No. 95-064, Presentation by Kate Faulkner, National Park Service, Channel Islands National Park

Interim Executive Officer Lisa Horowitz McCann introduced the item and Kate Faulkner of the National Park Service to the Board. Ms. Faulkner discussed the history of the island and long-term grazing management practices that impacted terrestrial habitat and water quality. In the 1800s, sheep were introduced to the island. In the late 1800s sheep were replaced by cattle. In 1998 the cattle were removed.

The removal of cattle improved water quality, reduced soil erosion, increased woody plant species, increased endangered species growth, and improved water capture and retention on Santa Rosa Island. The National Park Service will continue to monitor the island and provide information to the Water Board as requested.

Michael Thomas emphasized that the Water Board goal was improved cattle management to protect water quality, not removal of cattle.

Board members were invited to visit the island.

12. Status of Water Board Programs and Regulations to Protect Water Quality from Cannabis Cultivation Facilities

Erin Mustain, Senior Water Resources Engineer in the State Water Resources Control Board's Office of Enforcement, described the Office of Enforcement's efforts in the North Coast, Regional Water Quality Control Board, and the Central Valley Regional Water Quality Control Board to regulate cannabis cultivation. Both Regional Water Boards have developed regulatory orders and are implementing them now. Recent state laws require the Regional Water Quality Control Boards to regulate cannabis cultivation.

Board members had questions and comments about how the program would be implemented in the central coast and the status of local agency efforts. Lisa Horowitz McCann explained that we do not yet have staff resources for this effort, though we expect to have some in the next fiscal year, and that we have already started some coordination with local agencies.

13. Budget and Priorities

Lisa Horowitz McCann and Michael Thomas presented a brief description of the development of the Water Board's Vision, Measurable Goals and priorities. They further explained how the current budget allocates resources aligned with the priorities and, further, that staff implements or directs programs and individual projects per the current priorities.

Board members commented on the priorities and suggested changing the language to "promote" cleanup or protection, rather than "prevent" degradation. They also identified strategies to address sea water intrusion and asked staff to identify the actions currently being implemented, such as promoting and permitting recycled water projects to replenish groundwater. They commented on and asked questions about the staff process for making budget decisions and aligning work with priorities.

Board members requested more information to show what, when and how Board members can provide meaningful budget input, both to help direct distribution of current resources and to seek additional resources for underfunded or new work aligned with priorities.


