### **NOTICE OF PUBLIC HEARING** **Concerning a Proposed Amendment to the Water Quality Control Plan** **for the Central Coastal Basin to Establish Total Maximum Daily Loads for** **Organophosphate Pesticides and Toxicity in the Lower Salinas River Watershed,** **Monterey County, California**

**NOTICE IS HEREBY GIVEN** that the Central Coast Regional Water Quality Control Board (Central Coast Water Board) will hold a public hearing to consider an amendment to the Water Quality Control Plan for the Central Coastal Basin (Basin Plan) to adopt total maximum daily loads (TMDLs) for organophosphate pesticides and toxicity in the lower Salinas River watershed, Monterey County, California, and to adopt the Substitute Environmental Documentation (SED) prepared to comply with the California Environmental Quality Act (CEQA).

**Hearing Date and Location:** April 18-19, 2024. Prior to this regularly scheduled board meeting, an agenda will be posted on the [Central Coast Water Board website](#) <sup>1</sup> specifying which day the Basin Plan amendment will be considered.

This public hearing will occur via remote presence by video and teleconference and will also occur at the Central Coast Water Board office at 895 Aerovista Place, Suite 101, San Luis Obispo, CA 93401, accessible to persons with disabilities. The day may be subject to change, but any such changes will be posted on the foregoing website.
