NOTICE OF TRANSMITTAL OF PROPOSED ORDER

The State Water Resources Control Board
Administrative Hearings Office
held a public hearing on September 29, 2021,
on water-right application (A029657) of

The County of San Joaquin

for a permit to appropriate water from the
South Fork American River at the Freeport Regional Water Authority Facility
on the Sacramento River.

On June 10, 2021, the Administrative Hearings Office (AHO) of the State Water Resources Control Board (State Water Board or Board) issued a Notice of Public Hearing and Pre-Hearing Conference on the water-right application (A029657) of San Joaquin County.

On September 29, 2021, the AHO held a public hearing in this matter by Zoom.

The AHO released a draft proposed order in this matter for review and comment by the parties on January 27, 2022. The parties submitted their comments on the draft proposed order by the February 28, 2022 deadline.

The AHO has prepared its proposed order and transmitted it to the Clerk of the Board. Copies of this proposed order and the AHO's transmittal memorandum are enclosed. Also enclosed is a file that shows the changes from the January 27, 2022 draft proposed order to the enclosed proposed order.

Any interested party may submit, **by June 27, 2022**, a written request to the Board that includes an explanation of the reasons for the party's request, asking the Board to: (1) adopt the proposed order; (2) make technical or minor changes and adopt it as the Board's order; (3) reject the proposed order and remand the case to the AHO for further proceedings; or (4) reject the proposed order and decide the case upon the record or upon an agreed statement of the parties, with or without taking additional evidence. (Wat. Code, § 1114, subds. (c)(2) & (c)(4).)

If you want to submit a written request to the Board about the enclosed proposed order, you may e-mail it to the AHO at adminhrgoffice@waterboards.ca.gov, and include in the cc line of your e-mail the e-mail addresses of all other people on the service list for this matter. Alternatively, you may mail your request to the AHO. If you follow this procedure, please mail copies of your letter to all other people on the service list for this matter. The AHO will transmit written requests submitted by the deadline to the Clerk of the Board.

The AHO plans to ask the State Water Board to consider adopting this proposed order during the Board's July 19, 2022 meeting. The AHO will send parties to this hearing copies of the agenda of the Board meeting at which the Board will consider this proposed order, when the Clerk of the Board posts it, which normally is 10 days before the meeting. The agenda will specify the process for appearing at the Board meeting to make oral comments.
