### **NOTICE - LIFTING OF TERM 91 CURTAILMENT** **TERM 91 WATER RIGHT PERMIT 010477 (APPLICATION NO. A012842)**

Your Permit 010477 (A012842) contains a term (Standard Term 91) that prohibits diversion of water under specified conditions. These conditions occur when Supplemental Project Water from the Central Valley Project operated by the U.S. Bureau of Reclamation or the State Water Project operated by the California Department of Water Resources is being released to meet water quality standards and other in-basin entitlements in the Sacramento-San Joaquin Delta Watershed.

You are hereby notified that the State Water Resources Control Board has determined Supplemental Project Water is **NOT** being released in the Sacramento-San Joaquin Delta Watershed.

### **YOU CAN DIVERT WATER UNDER A012842 FROM NOW UNTIL NOTIFIED OF A CURTAILMENT**

**PLEASE NOTE: Curtailment under Term 91 may be re-established at any time if dry conditions persist.**
