HEARING TO REVIEW THE U.S. BUREAU OF RECLAMATION (BUREAU) WATER RIGHT PERMITS (APPLICATIONS 11331 AND 11332) TO DETERMINE WHETHER ANY MODIFICATIONS IN PERMIT TERMS OR CONDITIONS ARE NECESSARY TO PROTECT PUBLIC TRUST VALUES AND DOWNSTREAM WATER RIGHTS ON THE SANTA YNEZ RIVER BELOW BRADBURY DAM (CACHUMA RESERVOIR)

The State Water Resources Control Board has tentatively scheduled a hearing on the matter noted above for November 6, 7, 13 and 14, 2000. The hearing may also consider the petitions for change in the purpose and place of use filed by the Bureau. Formal notice of the exact time and place of hearing will be given at least 20 days prior to that date. The notice will contain a list of the hearing issues and procedures for participating in the hearing.
