STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 2007-0054

APPROVING AN AMENDMENT TO THE WATER QUALITY CONTROL PLAN FOR THE SAN FRANCISCO BAY REGION (BASIN PLAN) TO ESTABLISH A TOTAL MAXIMUM DAILY LOAD (TMDL) AND IMPLEMENTATION PLAN FOR PATHOGENS IN THE SONOMA CREEK WATERSHED

WHEREAS:

- The San Francisco Bay Regional Water Quality Control Board (San Francisco Bay Water Board) adopted a revised Basin Plan on June 21, 1995, approved by the State Water Resources Control Board (State Water Board) on July 20, 1995, and approved by the Office of Administrative Law (OAL) on November 13, 1995, and has since been revised.
- 2. On June 14, 2006, the San Francisco Bay Water Board adopted Resolution No. R2-2006-0042 (Attachment), amending the Basin Plan to establish a pathogen TMDL for the Sonoma Creek Watershed.
- 3. The State Water Board finds that the Basin Plan amendment is in conformance with Water Code section 13240, which specifies that Regional Water Quality Control Boards may revise Basin Plans, and section 13242, which requires a program of implementation of water quality objectives. The State Water Board also finds that the TMDL as reflected in the Basin Plan amendment is consistent with the requirements of federal Clean Water Act section 303(d).
- 4. The San Francisco Bay Water Board found that in the TMDL staff report, supporting documentation, the California Environmental Quality Act (CEQA) Checklist, and the response to comments contained analysis that comply with the requirements of the State Water Board's certified regulatory CEQA process as set forth in California Code of Regulations, Title 23, section 3775, et seq.
- 5. The San Francisco Bay Water Board has duly considered the Environmental Checklist, Staff Report, and supporting documentation with respect to environmental impacts and found that the Basin Plan amendment will not have a significant impact on the environment. Therefore, no alternatives or mitigation measures are required or proposed. The San Francisco Bay Water Board found that the Basin Plan amendment will result in no potential for adverse effects on wildlife. The San Francisco Bay Water Board has also considered the environmental analysis contained in the Staff Report of the reasonably foreseeable methods of compliance with the Basin Plan amendment, including economics.
- 6. The San Francisco Bay Water Board found that the Basin Plan amendment will ensure the reasonable protection of the beneficial uses of surface waters within the Region, and is consistent with the state Antidegradation Policy (State Water Board Resolution No. 68-16) and federal antidegradation requirements.
- 7. This Basin Plan amendment does not become effective until approved by the State Water Board and OAL. The TMDL must also be approved by the U.S. Environmental Protection Agency (U.S. EPA).

THEREFORE BE IT RESOLVED THAT:

The State Water Board:

- 1. Approves the amendment to the Basin Plan as adopted under San Francisco Bay Water Board Resolution No. R2-2006-0042.
- 2. Authorizes the Executive Director or designee to submit the amendment adopted under San Francisco Bay Water Board Resolution No. R2-2006-0042 to OAL for approval of the regulatory provisions and to U.S. EPA for approval of the TMDL.
