Pollutant control (prevention and restoration) strategies	Adopts plans, adopts waste discharge requirements, implements State Board policies and regulations.	Adopts statewide policies for water quality control, adopts regulations, and adopts general orders. Reviews petitions and adopts Water Quality orders.
Pollutant remediation (cleanup) strategies	Issues cleanup and abatement orders, cease and desist orders, investigative orders, and time schedule orders. Enforcement	Full authority to address any water quality enforcement issue with its region. Cleanup and abatement, cease and desist, administrative civil liability, and judicial referrals.	Limited authority to address water quality enforcement issues. Cleanup and abatement, administrative civil liability, and judicial referrals.
