**NOTICE OF PUBLIC HEARING
RESCISSION OF WASTE DISCHARGE REQUIREMENTS AND ENROLLMENT INTO
MASTER RECLAMATION REQUIREMENTS
FOR
COSTANOA LODGE AND CAMP WATER RECLAMATION FACILITY
SAN MATEO COUNTY**

Based on preliminary staff review and application of lawful standards and regulations, the California Regional Water Quality Control Board, Central Coast Region (Central Coast Water Board) tentatively proposes to rescind the Waste Discharge Requirements (WDR) for the Costanoa Lodge and Camp water reclamation facility and enroll them into a new Master Reclamation Requirements Order No. R3-2013-0010 (Draft Order).

The Costanoa Lodge and Camp operates a collection sewer system and a domestic wastewater reclamation facility that serves overnight stays by hotel guests and recreational vehicle owners. The Costanoa Lodge and Camp designed the domestic wastewater treatment and reclamation system to treat a daily average of 18,000 gallons per day of domestic wastewater. They reuse the treated and reclaimed water to irrigate landscape at the Costanoa Lodge and Camp facility.

People wanting to comment on or object to the Draft Order must submit comments in writing to the address above no later than **May 10, 2013**. The Central Coast Water Board will not accept comments or other written submissions on the Draft Order after **May 10, 2013**, unless the Regional Board Chair rules that exclusion would create a severe hardship and that the late submission will not prejudice any party or the Central Coast Water Board. Any person asking to submit late materials must explain why the materials were not submitted earlier. The Regional Board Chair will rule at or before the hearing. Late submissions that consist of evidence (as opposed to policy statements or comments) are generally prejudicial unless all designated parties and Central Coast Water Board staff have time to consider the evidence before the meeting.

The Central Coast Water Board will hold a public hearing to obtain public comment and consider rescinding WDR Order No. 89-23 and adopting Draft Order No. R3-2013-0010 at 8:30 a.m. on Thursday, July 11, 2013, at the:

The Water Board invites interested people to attend to express their views on permit rescission and adoption. People making presentations should confine their statements to these issues. For the accuracy of the record, all interested people shall submit important testimony in writing. Oral statements should be brief to allow all interested people time to be heard.
