SUBJECT: CENTRAL COAST WATER BOARD WORKSHOP, WEDNESDAY, FEBRUARY 1, 2012 IN SALINAS-Opportunity for Public Comment (Oral only) on the Draft Staff Recommendations for an Updated Agricultural Order (Order No. R3-2012-0011, 2012 Draft Agricultural Order)

SUMMARY

The Central Coast Water Board (Water Board) is holding a **workshop on Wednesday**, **February 1, 2012 in Salinas** regarding renewal and revision of the conditional waiver of waste discharge requirements for discharges from irrigated lands. The workshop has been scheduled at the request of interested persons to provide the opportunity for Board members, particularly the recently appointed Board members, to become more familiar with the record in this matter and to hear comments by the public on the proposed 2012 Draft Agricultural Order. In an Order issued on January 8, 2012, the Chair of the Water Board granted the request by the interested persons for the Board to hold an additional workshop.

At the workshop, staff will provide a brief summary of the current status of updating the Draft Agricultural Order and overall proceedings to date. The public will have an opportunity to make oral comments. The workshop is scheduled for three hours. The Water Board will generally provide three minutes per speaker unless a longer time is requested and granted. Persons wishing to have longer than three minutes to speak (with justification) to the Executive Officer must submit their requests (rbriggs@waterboards.ca.gov) of the Water Board by 5:00 p.m., January 18, 2012. Persons requesting additional time to speak will be informed by January 24th on whether the request has been granted. Note that the Water Board has provided two previous multi-hour hearings, two multi-hour workshops, and five opportunities to submit written comments. All Water Board members have been provided the record in this matter, including the staff reports, comments and responses to comments, and hearing and workshop audio and transcripts, if available. The Water Board expects that speakers will summarize their previous submittals, avoid repetition, and group similar presentations.

As the written record is now closed, no additional written comments will be accepted into the record.

At a hearing scheduled at the Water Board's regularly scheduled meeting on March 15, 2012, in San Luis Obispo, the Water Board will consider adoption of an Agricultural Order. Notice and process for that hearing will be published at a later date.

The latest version of the Draft Agricultural Order was made available to the public on August 16, 2011, in preparation for the postponed September 1, 2011 Board Meeting. The August 16, 2011 Staff Report includes redline-strikeout edits to the Draft Agricultural Order and Monitoring and Reporting Program, made in response to comments on previous versions of the Draft Agricultural Order distributed in preparation for the March 17, May 4, and September 1, 2011 Board Meetings. Table 1 summarizes the requirements of the 2012 Draft Agricultural Order.

DISCUSSION

Status of the Process to Update the Draft Agricultural Order

The Water Board scheduled a hearing for September 2011, to consider adoption of the Draft Agricultural Order. The hearing was noticed to the public as a Board Hearing if a quorum of Board Members was appointed, or another Panel Hearing if no quorum existed. Later the Water Board postponed the hearing due to lack of a Board quorum to consider the item.

In early November 2011, additional members were appointed to the Water Board, creating a quorum that could consider and act on the Draft Agricultural Order.

The Water Board has scheduled a workshop for February 1, 2012 at the request of interested persons.

At a hearing scheduled at the Water Board's regularly scheduled meeting on March 15, 2012, in San Luis Obispo, the Water Board will consider adoption of the 2012 Draft Agricultural Order. Notice and process for that hearing will be published at a later date.

Description of Overall Process to Update the Draft Agricultural Order

The process to renew the 2004 Agricultural Order began in December 2008. In the last three years, the Central Coast Water Board issued numerous order drafts and associated staff reports, held multiple public comment periods, convened numerous outreach events, and completed multiple extensions of the existing order. See Table 2 for a completed list of all outreach events.

The Water Board adopted a Conditional Waiver of Waste Discharge Requirements for Discharges from Irrigated Lands in 2004 (2004 Agricultural Order). In adopting the 2004 Agricultural Order, the Water Board found that the discharge of waste from irrigated lands had impaired and polluted the waters of the State and of the United States within the Central Coast Region, impaired the beneficial uses, and caused nuisance.

Staff initiated the process to update the Draft Agricultural Order in 2008. The Agricultural Order needed to be evaluated for an update for several reasons. First, the 2004 Agricultural Order was due to expire in five years, 2009. Additionally, the 2004

Agricultural Order did not directly address nitrate groundwater pollution at that time, did not include groundwater monitoring, and did not include conditions consistent with typical orders to control waste discharges from industries or activities affecting water quality in a similar level of severity. The 2004 Agricultural Order required surface receiving water monitoring but did not require individual monitoring or reporting to evaluate implementation effectiveness or pollution reduction from individual farm operations, not even those posing the highest risk to water quality and beneficial uses. Staff proposed to update the 2004 Agricultural Order to add discharge monitoring and reporting, verification of on-farm water quality improvements, and public transparency regarding on-farm discharges. The 2012 Draft Agricultural Order addresses these limitations.

During most of 2009, the Water Board convened an Agricultural Advisory group consisting of agricultural and environmental representatives to work on updating the Agricultural Order. On February 1, 2010, the Water Board released, for public review, a Preliminary Staff Draft Conditional Waiver of Waste Discharge Requirements for Discharges of Waste from Irrigated Lands (Preliminary Staff Draft Order) and received comments and alternative proposals to the Preliminary Staff Draft Order. The Water Board received alternative proposals from both agricultural and environmental stakeholder groups.

On May 12, 2010 and July 8, 2010, the Water Board held public workshops to provide an opportunity for public comments and recommendations for updating the 2004 Agricultural Order.

After considering various regulatory options and public comments received, including alternative proposals, the Water Board released a revised Draft Agricultural Order, Draft MRP, and staff report on November 19, 2010.

On March 1, 2011, the Water Board released a further revised Draft Agricultural Order and on March 17, 2011, initiated a Panel Hearing. The Panel Hearing was continued to May 4, 2011 to allow further opportunity for public input.

On August 16, 2011, staff released another addendum to the March 2011 staff report, including a few additional minor revisions, specifically in response to written comments submitted on the July 2011 version. Most of the written comments submitted in July and August 2011 duplicated previous comments so staff made only minimal revisions in response to a few new suggestions. The requirements of the 2012 Draft Agricultural Order are summarized in Table 1.

The Water Board scheduled a Board Hearing (if a quorum of Board Members was appointed) or another Panel Hearing (if no quorum existed) for September 2011. Later the Water Board postponed the hearing due to lack of a Board quorum to consider the item.

Because the Water Board did not renew the Agricultural Order before its five-year term expired, the Water Board extended the 2004 Agricultural Order four times beyond the original 2009 expiration date: on July 10, 2009, the Board without any substantive revisions for one year; on July 8, 2010, without any substantive revisions for a term

ending on March 31, 2011; on March 29, 2011, for six months; and on September 30, 2011 for one year. Therefore, the current order expires on September 30, 2012.

In November 2011, additional members were appointed to the Water Board, creating a quorum that could consider and act on the Draft Agricultural Order. The Water Board Hearing to consider the Final 2012 Draft Agricultural Order is scheduled for March 15, 2012.

Since the Water Board began the process to renew the Agricultural Order in 2008, staff has convened multiple public input opportunities and held numerous meetings with persons interested in the renewal of the 2004 Agricultural Order, including individuals and representatives of agricultural groups, environmental groups, and public health groups. Table 2 summarizes the various public input opportunities and stakeholder meetings and events to discuss the Agricultural Order renewal since November 2009.
