9. Informational Item on Cambria Community Services District, Emergency Water Supply Project, Cambria, San Luis Obispo County, Settled Administrative Civil Liability Complaint Order No. R3-2017-0015

Thea Tryon, Enforcement Coordinator for the Central Coast Water Board, provided an overview of the resolved administrative civil liability complaint that was issued to Cambria Community Services District for late reporting violations. Staff engineer Jon Rokke and Assistant Executive Officer Michael Thomas and Paul Ciccarelli, counsel with the Office of Enforcement, also addressed the Board.

The Executive Officer introduced the item and explained the separation of functions between the Prosecution Team and Advisory Team. The Executive Officer briefly summarized the proposed cease and desist order (CDO) and indicated that the Cambria Community Services District (CCSD) had agreed to the terms of the CDO as proposed. Jon Rokke of the Prosecution Team gave a presentation describing the regulatory background and violation history for the CCSD, and provided a detailed review of the CDO's requirements.

Tim Carmel, attorney for the CCSD, indicated the CCSD agreed with the proposed CDO and was likely to close and repurpose the surface impoundment to comply with the CDO. Jerry Gruber, General Manager of the CCSD, and Amanda Rice, CCSD Board of Directors President, summarized the events resulting in noncompliance, efforts to resolve noncompliance, and outlined possible options for disposal of surface impoundments brine and limitations and costs related to trucking wastewater. CCSD representatives requested

that the Water Board and staff consider costs in determining a reasonable timeline for disposal of surface impoundment contained waste.

The Board heard public comment from members of the public and deliberated on Item 10 during closed session. The Prosecution Team, Advisory Team, and CCSD discussed potential revisions to the CDO, including the addition of a compliance date. CCSD staff disagreed with the proposed changes and indicated their Board had only agreed not to contest the CDO as originally proposed. The Board did not revise the CDO and provided the following direction to the Executive Officer:

"Any workplan approval must be of sufficient detail to ensure that all current permit terms will be met at all times. If the pond continues in operation into the rainy season, the workplan must also incorporate the technical requirements of option 1 listed in the CDO. The third requirement may be satisfied by a demonstration that the liner system has not leaked. The second and fourth requirement may be satisfied through a third party who is approved by the Executive Officer, determining that the impoundment currently has the capacity to contain, and prevent inundation from, the 1,000-year, 24-hour precipitation event and that the five-foot separation from the bottom of the surface impoundment will be maintained. The workplan shall include a timeline for removing all wastes from the surface impoundment at the earliest possible date, but not to exceed five years."

# Educational Field Trip Managed Aquifer Recharge Projects
