3. Racial Equity / Environmental Justice Update – Progress Towards a Racial Equity Resolution for the Central Coast Region

Item 3 was an informational item to provide the Central Coast Water Board's Annual Environmental Justice (EJ) Update, which focused on the organization's efforts to advance racial equity. Board Chair Gray and Board Member Hunter provided opening remarks supporting the Central Coast Water Board's efforts to acknowledge the effects of institutional racism that have systematically impacted Black, Indigenous, and people of color, and to affirm the organization's role to prioritize racial equity. Board Member Hunter introduced the following three invited guest speakers who made presentations to the Board: Bidtah N. Becker (California Environmental Protection Agency) discussed CalEPA's perspective on environmental justice and racial equity; Dr. David Pellow (University of California, Santa Barbara) discussed environmental and climate justice initiatives in neighborhoods and carceral spaces, and: Ana Rosa Rizo-Centino (Central Coast Climate Justice Network) discussed the importance of creating an inclusive time and space for effective community engagement, so that communities can share their stories and participate in decision making.

Central Coast Water Bard staff member, Kathy Truong, described the historical contributions of Native American tribes, Asian Americans, and Hispanic and Latino/Latina/Latine communities to the Central Coast Region and the environmental and racial inequities they have experienced. Ms. Truong also presented data about the organization's demographics in comparison to the demographics of communities in the Central Coast Region, concluding that the Central Coast Water Board's workforce does not reflect the diverse communities in the region, especially Hispanic or Latino/Latina/Latine communities. Staff member, Sarah Treadwell, described the recent internal engagement activities conducted by the Central Coast Water Board, to enable staff to provide input regarding racial equity in the organization's work

culture and implementation of regulatory programs, and the upcoming opportunities for external engagement. Staff member, Katie McNeill, provided an update on the Central Coast Water Board's progress towards preparing a draft Racial Equity Resolution and invited the Board and the public to provide input on a preliminary draft resolution. Board Members expressed their support for the preliminary draft resolution and encouraged staff to be creative and consider nontraditional external engagement methods to maximize opportunities for public input. Board Members also suggested that staff consider improvements to shorten and simplify the resolution to maximize the readability of the resolution for all community members. Board Members described the importance of effective external engagement and encouraged staff to take the necessary time to meet people where they are, so that individuals and communities can participate in a way that feels inclusive and safe. Board Member Harlan presented several interesting historical references, including a painting titled "The First People of Capitola Fishing and Foraging at the Beach and Lagoon (2022), by local artist Ann Thiermann, a book titled *The Japanese in the Monterey Bay Region – A Brief History* (1997), by author Sandy Lydon, and a book titled Chinese Gold – the Chinese in the Monterey Bay Region (1997), also by author Sandy Lydon.

11. Central Coast Ambient Monitoring Program - Groundwater Assessment and Protection Funds Status and History

Item 11 was an informational item to provide an update of the Central Coast Ambient Monitoring Program - Groundwater Assessment and Protection (CCAMP-GAP). Environmental Scientist Julia Dyer provided an overview of the CCAMP-GAP Funds status and history since inception. The overview included the purpose of CCAMP-GAP, funding priorities, status of funds in the endowment and operational accounts, CCAMP-GAP funded projects, and next steps.

Ms. Dyer clarified that the funds for the Central Coast Ambient Monitoring Program (CCAMP), which implements surface water monitoring, and CCAMP-GAP are managed separately. Executive Officer Matthew Keeling clarified that Central Coast Water Board staff do not manage the funds; the Bay Foundation of Morro Bay manages the funds. Vice Chair Wolff stated that Item 11 is a good example of government transparency and described that the CCAMP-GAP endowment has been very fiscally prudent, and the projects have a very good technical foundation. Board Chair Gray stated that the staff report was very clear, and the program is well managed, and that CCAMP-GAP underscores the unique characteristics of our hydrologic region and the primacy of groundwater for communities in our area. Board Members expressed their support for prioritizing CCAMP-GAP resources to address environmental justice and the human right to water and implement the free Central Coast Drinking Water Well Testing Program. Additionally, Board Members

recognized the opportunity for CCAMP-GAP projects and data to support Sustainable Groundwater Management Act (SGMA).

Action Items

12. Pacific Gas and Electric Company Settlement - Proposed Funding Allocation Plan [Julia Dyer, Senior Environmental Scientist Specialist, 805/542-4624, <u>Julia.Dyer@waterboards.ca.gov</u>]

Item 12 was an action item for the Central Coast Water Board to consider Central Coast Water Board staff's recommendation to approve proposed Resolution No. R3-2022-0015 to allocate \$5.9 million in PG&E Settlement Funds. Environmental Scientist Julia Dyer provided an overview of the PG&E Settlement - Proposed Funding Allocation Plan including the proposed Resolution No. R3-2022-0015, draft Central Coast Community-Based Water Quality Grants Program – Draft Project Ranking and Selection Criteria, and public comments and staff responses to written comments received during the 30-day public comment period. Central Coast Water Board staff recommended distributing the \$5.9 million PG&E settlement funds over three allocation categories: 1) CCAMP-GAP Endowment (\$4.1 million), 2) Central Coast Drinking Water Well Testing Program (\$600K), and 3) public solicitation for individual grant projects (\$1.2 million).

Board Members discussed how the recommended increase in funds would support the Central Coast Drinking Water Well Testing program. Ms. Dyer explained that Central Coast Water Board staff estimates the \$600K would support the program for an additional three years (approximately 200 wells/year), and then the program would be supported by the endowment's annual revenue starting in year four. Ms. Dyer also confirmed that the funding would support outreach and education, and that the program is implemented in coordination with Community Water Center and other partners. Ms. Dyer further clarified that the plan is for the well testing program to extend to the southern part of the region in the near future. Vice Chair Wolff reminded staff that the Irrigated Lands Program will also require testing of approximately four thousand drinking water wells over the next two months through Ag Order 4.0

Board Members asked for clarification on the goals of the Central Coast Community-Based Water Quality Grants Program. Ms. Dyer explained that the grants program would reflect the goals of the CCAMP-GAP program and the Water Boards' Supplemental Environmental Project Policy, such as human right to water and environmental justice. Board Members expressed their support for partnering with the Rose Foundation and asked for more information on the proposed Funding Advisory Board (FAB) and selection process for members. Ms. Dyer stated that this process is the responsibility of the Rose Foundation. Jodene Isaacs of the Rose

Foundation explained that the FAB would be based on an existing network of contacts in the central coast region that have a good track record. Additionally, the Rose Foundation is open to recommendations from the Central Coast Water Board. Board Members also asked how the Central Coast Community-Based Water Quality Grants Program will support underrepresented communities. Jodene Isaacs explained that this is standard to their grant making process, for example projects including environmental justice will receive priority ranking. Tim Little, Director of the Rose Foundation, further clarified that the projects won't just benefit disadvantaged communities (DACs) but, they'll come from DACs and involve DACs. Additionally, the Rose Foundation staff is equipped to work with and support DACs. Board Members expressed their appreciation to the team for their work to develop the funding allocation plan.
