The Central Coast Regional Water Quality Control Board (Central Coast Water Board) is holding a public meeting to provide information, receive comments, and answer questions about the TCE groundwater investigation in the Buckley Road area of San Luis Obispo. Central Coast Water Board staff polled the community for the best date and time that suits their schedule and the following date and time were selected for the pubic informational meeting:

The Central Coast Water Board is the lead agency overseeing the investigation of TCE in groundwater and drinking water wells in the Buckley Road/Thread Lane/Davenport Creek Road/Evans Road/Angie Lou Lane/Three Sisters Road area (collectively referred to as the Buckley Road Area). The focus of the public meeting is to provide information on the current status of the TCE investigation and to provide an update on the well sampling results. Other topics include discussion of health risks associated with TCE and information on effective water filtration systems and treatment of TCE for home owners and businesses. The public meeting will also provide an opportunity for you to provide comments and ask questions.



Directions to Central Coast Water Board Office
