PROPOSED RESOLUTION NO. R3-2021-0098 APPROVING THE 2021 TRIENNIAL REVIEW OF THE WATER QUALITY CONTROL PLAN FOR THE CENTRAL COASTAL BASIN



WHEREAS, the California Regional Water Quality Control Board, Central Coast Region (hereafter Central Coast Water Board), finds:

- 1. The Water Quality Control Plan for the Central Coastal Basin (Basin Plan) was adopted on March 14, 1975 and has been amended since that date.
- 2. The Basin Plan establishes beneficial uses to be protected, water quality objectives, and a program of implementation needed for achieving water quality objectives for the waters within the Central Coast Region.
- 3. Section 303(c) of the federal Clean Water Act requires that water quality standards be reviewed and revised, if appropriate, on a triennial basis. Section 13240 of the California Water Code requires basin plans to be periodically reviewed and allows for their revision.
- 4. The Central Coast Water Board and its staff implemented the 2021 Triennial Review of the Basin Plan by performing the following:
 - Reviewing the Basin Plan, the past (2017) Triennial Review priority list, and soliciting proposals from Central Coast Water Board staff to develop a preliminary list of proposed Basin Plan amendments;
 - b. Sending email letters to the Region's electronic mailing list for Basin Planning/Triennial Review, with a notice of opportunity to comment on the preliminary list of proposed Basin Plan amendments during a 45-day public comment period between August 26, 2021 and October 11, 2021;
 - c. Posting the preliminary list of proposed Basin Plan amendments, and a staff report explaining the proposals, on the Central Coast Water Board's internet web page on August 26, 2021;
 - d. Noticing and conducting a public workshop meeting on September 28, 2021 via Zoom videoconferencing software;
 - e. Responding to public comments that were received;
 - f. Revising and evaluating the list of proposed Basin Plan amendments using six priority ranking criteria and consideration of technical staff and other resources to develop proposed amendments; and
 - g. Creating a priority list of proposed Basin Plan amendments based on the availability of technical staff and other resources to develop formal Basin Plan amendments and to develop scopes of work for Basin Plan amendments that are priority for assisting multiple Central Coast Water Board programs in implementing their program goals more effectively.

5. As a result of the 2021 Triennial Review process, Central Coast Water Board staff identified the priority proposals list shown in Attachment 1a.

THEREFORE, BE IT RESOLVED THAT:

The Central Coast Water Board, in fulfillment of the requirements of section 303(c) of the federal Clean Water Act and section 13240 of the California Water Code, has done the following:

- 1. Concluded the 2021 Triennial Review of the Basin Plan;
- 2. Approved the 2021 Priority List of Proposals to be Pursued as Basin Plan Amendments (Attachment 1a) with acknowledgement that this list does not preclude other Basin Plan revisions, which may become necessary before the next scheduled Triennial Review; and
- 3. Affirmed that those portions of the Basin Plan which were not proposed for revision as a part of this update process are generally adequate at this time.
