TIER UPDATE NOTIFICATION

Dear Mr. Conlan:

3C RANCH LLC., 15740 BLACKIE ROAD, SALINAS (AGL020001593) – SUBJECT TO TIER 2 REQUIREMENTS

On March 15, 2012, the Central Coast Regional Water Quality Control Board (Water Board) approved Order No. R3-2012-0011, Conditional Waiver of Waste Discharge Requirements from Irrigated Lands (Agricultural Order). The Agricultural Order addresses the discharge of waste from irrigated lands to groundwater and surface water. Wastes discharged from irrigated lands include but are not limited to pesticides, nutrients, and sediment that may be found in irrigation runoff, stormwater runoff, and percolation to groundwater. All enrolled ranches are classified into one of three tiers based on their potential risk to impair surface and groundwater. Higher tiers are subject to more stringent requirements.

You are receiving this notification because you have a ranch/farm enrolled in the Agricultural Order and the Water Board is updating your tier assignment. The Water Board periodically conducts tiering analyses of all enrolled ranches based on information reported in the electronic Notice of Intent (eNOI) and Department of Pesticide Regulation (DPR) Pesticide Use Reports. The criteria used for tiering is described in Part A of the Agricultural Order (p. 16-18).

The Water Board has reviewed the information for the ranch/farm identified below. Based upon our review and tiering analysis, the Water Board is updating the tier assignment for this ranch/farm. As of the date of this letter, you are responsible for complying with all requirements of your updated tier, including the submittal of an Annual Compliance Form by October 1, 2014 and annually thereafter. The enclosed Compliance Calendar lists key reporting requirements for all tiers.

If the characteristics of your ranch change such that the assigned tier may no longer apply per the tiering criteria of the Agricultural Order, or you believe any information may have been misreported or misinterpreted resulting in an incorrect tier assignment, please contact Water Board staff. Additionally, any person not satisfied with the Executive Officer's tier determination can file a request for Central Coast Water Board review.
