NOTICE OF PUBLIC HEARING and NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT

To Consider Adoption of a Total Maximum Daily Load for Nitrate in the Bell Creek Watershed, Santa Barbara County

The California Regional Water Quality Control Board Central Coast Region (Central Coast Water Board) will hold a public hearing to consider approval of a resolution to adopt a Total Maximum Daily Load (TMDL) for Nitrate in the Bell Creek Watershed (Resolution R3-2013-0012).

The purpose of the TMDL is to protect waters within the Bell Creek Watershed from water quality degradation due to elevated levels of nitrate. The resolution proposes numeric targets to protect beneficial uses, assigns allocations to achieve the numeric targets, and outlines an implementation and monitoring plan to gauge the success of achieving the TMDL. Components of the TMDLs are written in the Project Report.

Interested persons may submit written comments. Persons wishing to submit written comments on the proposed resolution to adopt a TMDL for Nitrate in the Bell Creek Watershed must submit comments in writing to the Central Coast Water Board at its office in San Luis Obispo no later than **March 16, 2013**. Late comments will not be accepted into the record unless approved by the Chair.
