**NOTICE OF FILING A DRAFT ENVIRONMENTAL DOCUMENT**

**To Consider Adoption of Resolution No. R3-2016-0003**  
**Amending the Water Quality Control Plan for the Central Coastal Basin to Adopt**  
**Total Maximum Daily Loads for Sediment Toxicity and Pyrethroid Pesticides in**  
**Sediment in the Lower Salinas River Watershed, Monterey County**

**NOTICE IS HEREBY GIVEN** that the Central Coast Regional Water Quality Control Board (Central Coast Water Board) will hold a public hearing **May 12-13, 2016** to consider adoption of a resolution amending the Water Quality Control Plan for the Central Coastal Basin (Basin Plan). The Basin Plan establishes measures to protect beneficial uses of waters of the state and achieve water quality objectives.

If accepted, the resolution will amend the Basin Plan by incorporating Total Maximum Daily Loads (TMDLs) for Sediment Toxicity and Pyrethroid Pesticides in Sediment in the Lower Salinas River Watershed.

At the conclusion of the hearing the Central Coast Water Board will consider approval of the proposed resolution.

Actions to amend the Basin Plan by the Central Coast Water Board will be taken in accordance with a regulatory program exempt under section 21080.5 of the Public Resources Code from the requirement to prepare an environmental impact report under the California Environmental Quality Act (Public Resources Code, section 21000 et seq.) and with other applicable laws and regulations.

Copies of the final draft resolution and amendments to the Basin Plan (including the staff report, a substitute environmental document, which includes an environmental checklist, and draft amendments for adoption) will be available on or about **May 2, 2016** at the following website:

Note that a separate notice for public comment was previously transmitted on January 20, 2016. The public comment period commenced on January 20, 2016 and ended on March 7, 2016. Therefore, Central Coast Water Board staff is not accepting further written comments at this time. Oral comments may be provided to the Central Coast Water Board at the public hearing shown below.

Time limits may be imposed on oral presentations at the hearing. At the conclusion of the public hearing, the Central Coast Water Board will consider certification of the substitute environmental documents and approval of the proposed amendments. The Central Coast Water Board may close the public hearing and the comment period, but consider adoption of the amendments at a later public hearing.
