CHANGE OF OWNERSHIP AND FACILITY NAME; FORMER DODGE RIDGE SKI AREA WASTEWATER TREATMENT FACILITY; NOTICE OF APPLICABILITY 97-10-DWQ-R5078; TUOLUMNE COUNTY

On 20 August 2021, the Central Valley Regional Water Quality Control Board received a signed Form 200 for a change of ownership and change in facility name of the former Dodge Ridge Ski Area Wastewater Treatment Facility (WWTF). The WWTF was enrolled under *Water Quality Order No. 97-10-DWQ, General Waste Discharge Requirements for Discharges to Land by Small Domestic Wastewater Treatment Systems* on 15 June 2011 (Notice of Applicability [NOA] 97-10-DWQ-R5078). The August 2021 Form 200 lists the new Facility name as Dodge Ridge Resort Wastewater Treatment Facility and the Facility owner as Dodge Ridge Mountain Resort LLC.

This letter serves as an official notice that Dodge Ridge Mountain Resort LLC is responsible for complying with NOA No. 97-10-DWQ-R5078 and General Order No. 97-10-DWQ (including the Monitoring and Reporting Program [Attachment A]). Please note that Dodge Ridge Mountain Resort LLC is required to submit self-monitoring reports specified MRP No. 97-10-DWQ and pay future annual fees.
