

NOTICE OF TERMINATION; GENERAL ORDER R5-2008-0149-026, FORMER M&M MINI MART, 1085 EAST STREET, WOODLAND, YOLO COUNTY (LUSTIS NO. 570301)

Thank you for submitting the 27 January 2015 *Request for Termination of Permit to Discharge*, under General Order No. R5-2008-0149-026, prepared on your behalf by your consultant, Geocon Consultants, Inc. (Geocon) for the former M&M Mini Mart at 1085 East Street in Woodland (Site). On 14 January 2011, the Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board) issued a Notice of Applicability under General Order No. R5-2008-0149 for General Waste Discharge Requirements for In-Situ Groundwater Remediation at Sites with Volatile Organic Compounds, Nitrogen Compounds, Perchlorate, Pesticides, Semi-Volatile Compounds and/or Petroleum Compounds. The Project was issued Facility ID No. 5A57NC00031. This Project's active remediation was completed on 19 December 2012, but remediation system equipment remained onsite during post remediation groundwater monitoring and additional work performed in 2014 to evaluate the limits of the groundwater plume.

General Order No. R5-2008-0149-026 is hereby terminated as of 25 March 2015, when Central Valley Water Board staff concurred with Geocon to continue post remediation monitoring. You may now remove remediation equipment from the Project site.
