MONITORING AND REPORTING PROGRAM NO. R5-2015-0012-068 FOR IN-SITU GROUNDWATER REMEDIATION AND DISCHARGE OF TREATED GROUNDWATER TO LAND

This Monitoring and Reporting Program (2021 MRP) describes requirements for monitoring a pilot-scale treatment of groundwater for Nutrien Ag Solutions, Inc. (Nutrien), Modesto facility at 3348 Claus Road in Modesto (Site). This MRP is issued pursuant to Water Code Section 13267. The Discharger shall not implement any changes to this MRP unless and until a revised MRP is issued by the Executive Officer. As appropriate, California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board) staff shall approve specific sample station locations prior to implementation of sampling activities.

All samples should be representative of the volume and nature of the discharge or matrix of material sampled. The time, date, and location of each grab sample shall be recorded on the sample chain of custody form.

GROUNDWATER MONITORING

As shown on Figure 1, there are multiple monitoring wells associated with the Site, and seven of these are associated with this remediation pilot study. The monitoring wells associated with this study are MMW-03A, MMW-16A, MMW-24A, MMW-26A, MMW-27A, MMW-28A, and MMW-29A. Currently, a separate Monitoring and Reporting Program R5-2019-0897 (2019 MRP) requires semi-annual groundwater monitoring, which will continue to be implemented in addition to the activities presented herein. If duplicative sampling is ordered between the two monitoring programs, a single sample will suffice for both reporting objectives. Duplication of monitoring efforts is not intended nor shall the 2021 MRP be interpreted to permit noncompliance with the minimum requirements of the 2019 MRP.

The groundwater monitoring program for these 7 remediation wells and any remediation monitoring wells installed subsequent to the issuance of this MRP shall be sampled according to the schedule in Table 1 and the samples shall be analyzed by the methods in Table 2. Sample collection and analysis shall follow standard EPA protocol.

 3 If, based on the most recent sample results, 1,2,3-trichloropropane is expected to exceed 0.02 ug/L, EPA Method 504.1 may be used for analysis. Similarly, if 1,2,3-trichloropropane is expected to exceed 5 ug/L, EPA Method 8260B may be used. If 1,2,3-TCP is not detected greater than 0.02 µg/L, then SRL 524M-TCP must be used in the next regularly scheduled sampling event and thereafter unless otherwise approved by Central Valley Water Board staff.

FIELD SAMPLING

In addition to the above sampling and laboratory analyses, field sampling and analysis shall be conducted each time a monitoring well or extraction well is sampled. The sampling and analysis of field parameters shall be as specified in Table 3.

All wells that are purged shall be purged until pH, temperature, conductivity and dissolved oxygen are within approximately 10% of the previous value.

Field test instruments (such as those used to test pH and dissolved oxygen) may be used provided that:

- 1. The operator is trained in proper use and maintenance of the instruments;
- 2. The instruments are calibrated prior to each monitoring event;
- 3. Instruments are serviced and/or calibrated by the manufacturer at the recommended frequency; and
- 4. Field calibration reports are submitted as described in item (b) of the "Reporting" section of this MRP.

IN-SITU DISCHARGE MONITORING

The Discharger shall monitor daily the discharge of water and amendments that are injected into the groundwater according to the requirements specified in Table 4. Each amendment addition shall be recorded individually, along with information regarding the time period over which the amendment was injected into the aquifer.

AMENDMENT ANALYSIS

Central Valley Water Board staff has received the analytical analysis of 3-D Microemulsion (3-DME) from the manufacturer.

ESTABLISHMENT OF BACKGROUND CONCENTRATION VALUES

The Discharger submitted a proposal to develop background (baseline) concentration values in all compliance wells MMW-26A and MMW-28A and in upgradient wells MMW-03A and MMW-16A. Background concentrations of constituents such as dissolved iron, dissolved manganese, potassium, chloride, and total dissolved solids in groundwater will be developed from four quarters of monitoring in these wells and continuing semi-annual monitoring.

REPORTING

When reporting the data, the Discharger shall arrange the information in tabular form so that the date, the constituents, and the concentrations are readily discernible. The data shall be summarized in such a manner as to illustrate clearly the compliance with this Order. The results of any monitoring done more frequently than required at the locations specified in the Monitoring and Reporting Program shall also be reported to the Central Valley Water Board.

As required by the California Business and Professions Code Sections 6735, 7835, and 7835.1, all reports shall be prepared by a registered professional Civil Engineer or Geologist or their subordinate and signed by the registered professional.

The Discharger shall submit quarterly electronic data reports, which conform to the requirements of the California Code of Regulations, Title 23, Division 3, Chapter 30. The quarterly reports shall be submitted electronically over the internet to the Geotracker database system by the 1st day of the second month following the end of each calendar quarter by

1 February, 1 May, 1 August, and 1 November for the first four quarters. Following the first year of data collection, the frequency of data submittals becomes semi-annually until such time as the Executive Officer determines that the reports are no longer necessary.

The reports required by this General Order Monitoring and Reporting Program may be combined with the reports required by Monitoring and Reporting Program No. R5-2019-0897. Two separate reports documenting the same time period are not required.

Each quarterly and semi-annual report shall include the following minimum information:

- (a) a description and discussion of the groundwater sampling event and results, including trends in the concentrations of pollutants and groundwater elevations in the wells, how and when samples were collected, and whether the pollutant plume(s) is delineated;
- (b) field logs that contain, at a minimum, water quality parameters measured before, during, and after purging, method of purging, depth of water, volume of water purged, etc.;
- (c) groundwater contour maps for all groundwater zones, if applicable;
- (d) pollutant concentration maps for all groundwater zones, if applicable;
- (e) a table showing well construction details such as well number, groundwater zone being monitored, coordinates (longitude and latitude), ground surface elevation, reference elevation, elevation of screen, elevation of bentonite, elevation of filter pack, and elevation of well bottom;
- (f) a table showing historical lateral and vertical (if applicable) flow directions and gradients;
- (g) cumulative data tables containing the water quality analytical results and depth to groundwater;
- (h) a copy of the laboratory analytical data report;
- (i) the status of any ongoing remediation, including an estimate of the cumulative mass of pollutant removed from the subsurface, system operating time, the effectiveness of the remediation system, and any field notes pertaining to the operation and maintenance of the system; and
- (j) if applicable, the reasons for and duration of all interruptions in the operation of any remediation system, and actions planned or taken to correct and prevent interruptions.

An Annual Report shall be submitted to the Central Valley Water Board by **1 November** of each year. This report shall contain an evaluation of the effectiveness and progress of the investigation and remediation. The Annual Report may be substituted for the fourth quarter (or

second semi-annual) monitoring report as long as it contains all of the information required for that report plus that required for the Annual Report. The Annual Report shall contain the following minimum information:

- (a) both tabular and graphical summaries of all data obtained during the year;
- (b) groundwater contour maps and pollutant concentration maps containing all data obtained during the previous year;
- (c) a discussion of the long-term trends in the concentrations of the pollutants in the groundwater monitoring wells;
- (d) an analysis of whether the pollutant plume is being effectively treated;
- (e) a description of all remedial activities conducted during the year, an analysis of their effectiveness in removing the pollutants, and plans to improve remediation system effectiveness;
- (f) an identification of any data gaps and potential deficiencies/redundancies in the monitoring system or reporting program; and
- (g) if desired, a proposal and rationale for any revisions to the groundwater sampling plan frequency and/or list of analytes.

A letter transmitting the monitoring reports shall accompany each report. Such a letter shall include a discussion of requirement violations found during the reporting period, and actions taken or planned for correcting noted violations, such as operation or facility modifications. If the Discharger has previously submitted a report describing corrective actions and/or a time schedule for implementing the corrective actions, reference to the previous correspondence will be satisfactory. The transmittal letter shall contain the penalty of perjury statement by the Discharger, or the Discharger's authorized agent, as described in the Standard Provisions General Reporting Requirements Section B.3.

The Discharger shall implement the above monitoring program on the first day of the month following adoption of this Order.




Figure 1. Remediation Monitoring Well Locations
