PUBLIC HEARING

CITY OF YUBA CITY
WASTEWATER TREATMENT PLANT
SUTTER COUNTY

The City of Yuba City (hereinafter Discharger) owns and operates the Yuba City Wastewater Treatment Plant (WWTP) located in Sutter County. The Discharger is currently regulated by Order No. R5-2003-0085 (existing NPDES permit). A tentative renewed NPDES permit was issued for public comment on 20 August 2007. Staff determined that a time schedule for compliance with final effluent limitations for iron must be in an enforcement Order. The proposed Time Schedule Order requires full compliance with the iron effluent limitation by 18 May 2010, includes a requirement to develop and implement a pollution prevention plan for iron, and includes an interim limitation as was proposed in the tentative NPDES permit. The public comment period for the iron limitations and compliance schedule has closed. Comments will only be accepted regarding whether the schedule should be in the NPDES permit or a Time Schedule Order.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than **22 October 2007**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Regional Board no later than by noon on **22 October 2007**. Written evidence or comments submitted after noon on **22 October 2007** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Regional Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
