INDUSTRIAL WASTEWATER TREATMENT PLANT
TEHAMA COUNTY

Bell-Carter Olive Company, Inc. and City of Corning (hereinafter Discharger) currently discharge treated olive waste to the Sacramento River, pursuant to Order Nos. 5-00-113 and R5-2004-0074, National Pollutant Discharge Elimination System (NPDES) Permit No. CA0083721. The Discharger is currently regulated by Order No. 5-00-113 and Special Order No. R5-2004-0074, which were adopted on 16 June 2000 and 4 June 2004 respectively. The treatment system consists of pretreatment (screening and dissolved air flotation) followed by biological treatment in aerated Class II Surface Impoundments with sedimentation and membrane filtration. The Class II Surface Impoundments are regulated pursuant to Order No. 5-00-114. The discharge is classified as a minor discharge.

A public hearing concerning this matter will be held during the Central Valley Regional Water Quality Control Board (Regional Water Board) meeting, which is scheduled for:

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide

comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Regional Water Board no later than 26 November 2007. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

The tentative Waste Discharge Requirements were issued on **28 September 2007**. Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Regional Water Board no later than by noon on **29 October 2007**. Written evidence or comments submitted after noon on 29 October 2007 will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
