

## TENTATIVE TIME SCHEDULE ORDER MARLEY COOLING TOWER COMPANY SAN JOAQUIN COUNTY

### TO ALL CONCERNED PERSONS AND AGENCIES:

Enclosed are the tentative Time Schedule Order (TSO) and the Notice of Public Hearing (NOPH) for the groundwater treatment plant at the Marley Cooling Tower Company's (MCTC) former Stockton facility. The tentative TSO proposes (1) extending the compliance schedule for total dissolved solids (TDS) from February 2008 to February 2012 (that is to say, the compliance schedule for meeting the final effluent limitation of 500 milligrams per liter [mg/l]); and (2) establishing an interim effluent limitation of 850 mg/l for TDS. The current TDS effluent limitation of 1,000 mg/l is specified in the applicable NPDES permit, Order No. R5-2003-0030.

The tentative TSO is scheduled to be heard at the January 2008 Regional Water Quality Control Board (Regional Water Board) meeting. Any comments you may have regarding the enclosed document must be submitted to the Regional Water Board office by 12:00 p.m. (noon) on **18 January 2008** to be given full consideration prior to the January 2008 Regional Water Board meeting. Comments submitted after 12:00 p.m. (noon) on **18 January 2008** may not be considered.
