Simpson Paper Company owns and operates the Dersch Road Class III Landfill (Facility) on Assessor Parcel Number 057-220-046. These Waste Discharge Requirements (WDRs) are being revised to rescind WDR Order No. 96-079, prescribe post-closure maintenance requirements and gas condensate discharge specifications for the Facility, and revise the Facility monitoring requirements in accordance with Title 27 of California Code of Regulations, Division 2, Subdivision 1.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than **9 June 2008**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

The revised Tentative Waste Discharge Requirements was issued on **24 April 2008**. Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Regional Board no later than by noon on **9 June 2008**. Written evidence or comments submitted after noon on **9 June 2008** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Regional Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair
