TENTATIVE ORDER
AMENDING WASTE DISCHARGE REQUIREMENTS ORDER NO. R5-2007-0109
FOR
RANCHO MURIETA COMMUNITY SERVICES DISTRICT
VAN VLECK RANCH RECYCLED WATER REUSE AREAS
SACRAMENTO COUNTY**

TO ALL CONCERNED PERSONS AND AGENCIES:

On 2 August 2007, the Central Valley Regional Water Quality Control Board, (Central Valley Water Board) adopted Waste Discharge Requirements (WDRs) Order No. R5-2007-0109 for Rancho Murieta Community Services District (RMCS D) in Sacramento County. The WDRs prescribe requirements for reuse of tertiary disinfected wastewater produced by the RMCS D wastewater treatment facility (WWTF) at the Van Vleck Ranch.

The WDRs allow water recycling at Van Vleck Ranch for a limited term only, through 31 December 2009. On 6 January 2009, RMCS D submitted an amended Report of Waste Discharge (RWD) to apply for an extension of the term of Order No. R5-2007-0109 to 31 December 2012.

The Central Valley Water Board will consider adoption of an amendment to WDRs Order No. R5-2007-0109. The proposed amendment changes the expiration date of the WDRs to 31 December 2012 instead of 31 December 2009. The proposed amendment also requires that RMCS D complete a full CEQA environmental review of the project, obtain a Use Permit, and obtain new WDRs before continuing the discharge after that date.
