RESCINDING CEASE AND DESIST ORDERS

- a) On 23 April 2003, the Central Valley Water Board adopted Cease and Desist Order (CDO) R5-2003-0056 for the Courtland WWTF. The treatment system was owned and operated by Sacramento County Sanitation District No. 1, (now Sacramento Area Sewer District). The CDO required that the Discharger address: (a) seepage of wastewater, (b) pond berm instability, (c) discharges of wastewater to surface water via a French drain system, and (d) groundwater degradation. The Discharger decided to close the WWTF and convey wastewater to the Sacramento Regional Wastewater Treatment Plant (SRWTP) in Elk Grove. The Discharger has completed closure of the wastewater ponds in accordance with an approved workplan. All wastewater is now conveyed to the SRWTP. Therefore, Cease and Desist Order R5-2003-0056 is no longer necessary.
- b) Cease and Desist Order (CDO) R5-2004-0113, issued on 10 September 2004, required the State of California, Department of Fish and Game (Discharger), to comply with Waste Discharge Requirements, Order R5-2004-0112 (NPDES No. CA0004561), Darrah Springs Fish Hatchery, Shasta County. The CDO required full compliance with Effluent Limitation B.3. for copper by 1 September 2009. The Discharger complied with the CDO by discontinuing the use of copper or chelated copper compounds. Therefore, Cease and Desist Order R5-2004-0013 is no longer needed.
- c) Cease and Desist Order (CDO) R5-2004-0115, was issued on 10 September 2004, required the State of California, Department of Fish and Game (Discharger), to comply with Waste Discharge Requirements, Order R5-2004-0114 (NPDES No. CA0004588), Crystal Lake Fish Hatchery, Shasta County. The CDO required full compliance with Effluent Limitation B.3. for copper by 1 September 2009. The Discharger complied with the CDO by discontinuing the use of copper or chelated copper compounds. Therefore, Cease and Desist Order R5-2004-0015 is no longer needed.
- d) Cease and Desist Order (CDO) R5-2004-0117, issued on 10 September 2004, required the State of California, Department of Fish and Game, to comply with Waste Discharge Requirements, Order R5-2004-0116 (NPDES No. CA0004596), Mount Shasta Fish Hatchery, Siskiyou County. The CDO required full compliance with Effluent Limitation B.3. for copper by 1 September 2009. The Discharger complied with the CDO by discontinuing the use of copper or chelated copper compounds. Therefore, Cease and Desist Order R5-2004-0017 is no longer needed.

IT IS HEREBY ORDERED that the above Cease and Desist Orders are rescinded.
