

### **FAILURE TO REMOVE ABOVEGROUND TANK AND CLARIFIER/HOLDING BASIN WASTES, WINEMUCCA TRADING COMPANY LIMITED, INC., FORMER SHASTA PULP AND PAPER MILL, SHASTA COUNTY, SCP #2050189, CAO NO. R5-2004-0717**

In June 2008, California Regional Water Quality Control Board Central Valley Region (Regional Water Board) staff approved work plans to remove black liquor, coke, lime, and other residual paper mill substances stored in aboveground tanks and waste stored in clarifiers/holding basins at the Winemucca Trading Company Limited, Inc (Winemucca), Former Shasta Pulp and Paper Mill. Staff requested removal of the aboveground tank wastes, **by 1 September 2008**, and the clarifiers/holding basin wastes **by 1 October 2008**. Winemucca initiated work but, to date, has failed to complete the waste removal activities. You are hereby directed to complete the work identified above.

Staff intends to discuss Administrative Civil Liability Complaint No. R5-2008-0518 at the 5/6 February 2009 Regional Water Board meeting.


