NOTICE OF PUBLIC HEARING

**RENEWAL OF WASTE DISCHARGE REQUIREMENTS
AND
NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT
(NPDES NO. CA0083046)
FOR
THE VENDO COMPANY
GROUNDWATER REMEDIATION SYSTEM
FRESNO COUNTY**

The Vendo Company is the owner and operator of a Groundwater Remediation System (Facility), a groundwater extraction and treatment facility. The Facility is in the City of Fresno (Pinedale area) at 698 West Locust Avenue. The Facility consists of groundwater extraction wells and two 20,000-pound granular activated carbon (GAC) units. Treated groundwater is discharged to the Fresno Irrigation District's Bullard Canal, which is hydraulically connected to the San Joaquin River, a water of the United States. Waste Discharge Requirements (WDRs) Order R5-2006-0016 (NPDES No. CA0083046) currently regulates the discharge of treated groundwater from the Facility.

The Central Valley Regional Water Quality Control Board (Central Valley Water Board) will consider adoption of WDRs renewing the NPDES permit. The proposed WDRs/NPDES permit include final effluent limitations for flow, copper, zinc, 1,1-dichloroethane, 1,1,-dichloroethylene, cis-1,2-dichloroethylene, tetrachloroethylene, trichloroethylene, pH, acute and chronic whole effluent toxicity.

The designated parties for this hearing are as follows:

Designated parties, but not interested persons will have these rights: to call and examine witnesses; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. Central Valley Water Board staff will prepare the administrative record, and may present evidence, make an oral presentation and cross-examine opposing witnesses.

Interested persons may not cross-examine witnesses and will not be subject to cross-examination. Interested persons may submit evidence (e.g., photographs, eyewitness testimony, monitoring data) if the evidence is submitted in accordance with the deadlines for submitting evidence described below. Interested persons who present evidence may be subject to cross-examination. Interested persons may request status as a designated party for purposes of this hearing by submitting such request in

writing to the Central Valley Water Board no later than **11 March 2013**. The request must explain the basis for status as a designated party and, in particular, how the person is affected by the discharge.

Persons wishing to comment on this hearing item must submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than **5 p.m. on 11 March 2013**. Testimony, evidence, and/or written comments submitted after **5 p.m. on 11 March 2013** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Central Valley Water Board hearing and are expected to orally summarize their written submittals. Oral testimony and cross-examination will be limited in time by the Board Chair. Both designated parties and interested persons may be asked to respond to clarifying questions from Board members, counsel, staff, or others at the discretion of the Central Valley Water Board.


