FLORIN PERKINS LANDFILL
UNCLASSIFIED LANDFILL UNITS
CLOSURE AND CORRECTIVE ACTION
SACRAMENTO COUNTY

This 56-acre, unlined landfill was developed in a gravel quarry pit along Florin Perkins Road near the Jackson Highway. The unclassified landfill operated from 1993 to 2005, accepting primarily inert waste. The facility had a history of noncompliance and was the subject of enforcement actions by the Central Valley Water Board and Local Enforcement Agency. Monitoring data indicates that the landfill is generating landfill gas and that groundwater beneath the site has been impacted with low concentrations of volatile organic compounds and slightly elevated general minerals. The proposed Order prescribes revised waste discharge requirements for landfill closure and corrective action to address these impacts.

Interested persons may not cross examine witnesses, and will not be subject to cross examination. Interested persons may submit evidence (e.g., photographs, eye-witness

testimony, monitoring data) if the evidence is submitted in accordance with the deadlines for submitting evidence described below. Interested persons who present evidence may be subject to cross-examination. Interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than **22 April 2013**. The request must explain the basis for status as a designated party and in particular how the person is affected by the discharge.

Tentative waste discharge requirements for the facility were issued for public comment on 20 March 2013. Persons wishing to comment on this item must submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than by noon on **22 April 2013**. Written materials submitted after noon on the above date will not be accepted and will not be incorporated into the administrative record absent a ruling by the Chair. A party requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that the late submission would not prejudice the Central Valley Water Board or any designated party.

All designated parties and interested persons may speak at the Regional Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair. Both designated parties and interested persons may be asked to respond to clarifying questions from Board members, counsel staff or others, at the discretion of the Board.
