TIME SCHEDULE ORDER R5-2009-0005
FOR
NEVADA COUNTY SANITATION DISTRICT NO. 1
LAKE WILDWOOD WASTEWATER TREATMENT PLANT
NEVADA COUNTY

The California Regional Water Quality Control Board, Central Valley Region, (hereafter referred to as Central Valley Water Board) finds that:

1. The Nevada County Sanitation District No. 1 (Discharger) owns and operates the Lake Wildwood Wastewater Treatment Plant. The Discharger is regulated under Waste Discharge Requirements Order R5-2009-0004 (NPDES No. CA0077828).
2. On 5 February 2009, the Central Valley Water Board adopted Time Schedule Order (TSO) R5-2009-0005. The TSO required full compliance with the dibromochloromethane and dichlorobromomethane effluent limitations by 30 September 2013. The TSO provided interim effluent limitations for dibromochloromethane and dichlorobromomethane "...through 30 September 2013, or when the Discharger is able to come into compliance with the final effluent limitations, whichever is sooner."
3. As of 1 February 2013, the Discharger had achieved compliance with the dibromochloromethane and dichlorobromomethane effluent limitations after constructing an ultraviolet disinfection system. The Discharger has fully complied with the effluent limitation requirements, has met the intent of the CDO, and no longer requires protection from Mandatory Minimum Penalties. Therefore, it is appropriate to rescind the CDO.
4. The Central Valley Water Board has notified the Discharger and interested agencies and persons of its intent to rescind Order R5-2009-0005 and has provided them with an opportunity for a public hearing and an opportunity for them to submit their written views and recommendations.
5. Issuance of this Order is exempt from the provisions of the California Environmental Quality Act (Public Resources Code section 21000 et seq.), in accordance with California Code of Regulations, title 14, section 15321(a) (2).
6. The Central Valley Water Board, in a public meeting, heard and considered all comments and evidence pertaining to this matter.
