NOTICE OF PUBLIC HEARING

The City of Davis is the owner and operator of the City of Davis Wastewater Treatment Plant (Facility), located at 45400 County Road 28H in Davis. The Facility provides sewerage service for the community of Davis. The Facility discharges treated wastewater at two locations, Willow Slough Bypass and Conaway Ranch Toe Drain, both of which are within the Yolo Bypass and the Sacramento River Watershed.

Discharges from the Facility are currently regulated by Order R5-2007-0132-02, an NPDES permit amended by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 23 September 2010. The proposed NPDES permit renewal includes effluent limitations for aluminum, copper, iron, and selenium to which the Discharger cannot immediately comply. A new Time Schedule Order is proposed allowing a compliance schedule for compliance with final effluent limitations for aluminum, copper, iron, and selenium required in the proposed permit.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 20 June 2013**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than **5:00 p.m. on 20 June 2013**. Written evidence or comments submitted after **5:00 p.m. on 20 June 2013** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
