NOTICE OF PUBLIC HEARING

The City of Lincoln is the owner and operator of the City of Lincoln Wastewater Treatment and Reclamation Facility (Facility), a publically owned treatment works located at 1245 Fiddymont Road, Lincoln, California. The Facility provides sewerage service for the City of Lincoln and western Placer County and serves a population of approximately 43,000. The Facility provides tertiary level treatment for up to 4.2 MGD. The Discharger is currently expanding the Facility as part of a regionalization project with the Placer County Sewer Maintenance District 1 Wastewater Treatment Plant that will increase the total capacity of the Facility to 5.9 MGD. Treated wastewater from the Facility is discharged to Auburn Ravine Creek, which flows to East Side Canal, Natomas Cross Canal, and is ultimately discharged to Sacramento River, a water of the United States.

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2008-0156, issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 23 October 2008. An Order is proposed to renew the NPDES permit.

The designated parties for this hearing are as follows:

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 26 December 2013**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than **5:00 p.m. on**

26 December 2013. Written materials or comments, including emails, submitted after **5:00 p.m. on 26 December 2013** will not be accepted and will not be incorporated into the administrative record absent a ruling by the Chair. Any person requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that accepting the late submission will not prejudice the Central Valley Water Board or any Designated Party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
