KINGS COUNTY**

The Kings Waste and Recycling Authority (hereafter referred to as Discharger) owns and maintains the closed Hanford Municipal Solid Waste Landfill at the intersection of State Highway 43 and the Hanford-Armona Road about 2.5 miles southwest of the City of Hanford in the NE ¼ of Section 4, T19S, R22E MDB&M. The facility currently contains one existing unlined waste management unit (Unit) covering 79 acres at the northern one-half of the facility. The Unit was closed with an engineered alternative composite final cover system in 1999. The Unit has released inorganic waste constituents and volatile organic compounds (VOCs) to groundwater. The facility is currently regulated by Waste Discharge Requirements Order R5-2007-0154, which prescribes requirements for postclosure maintenance and Cleanup and Abatement Order No. 96-706, which prescribes, in part, requirements for completing an evaluation monitoring program, completing an engineering feasibility study for corrective action, and establishing and implementing a corrective action program.

The Discharger proposes to remediate volatile organic compounds (VOCs) utilizing a groundwater extraction/aeration system and increasing landfill gas extraction in areas where the most significant concentrations of total VOCs in landfill gas and groundwater have been detected. Treated effluent from the aeration system is proposed to be discharged to on-site evaporation/percolation basins.

The proposed order provides for postclosure maintenance and the implementation of corrective action.

A public hearing concerning this matter will be held during the Central Valley Regional Water Quality Control Board (Central Valley Water Board) meeting, which is scheduled for:

The designated parties for this hearing are as follows:

Designated parties, but not interested persons, will have these rights: to call and examine witnesses; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. Central Valley Water Board staff will prepare the administrative record, and may present evidence, make an oral presentation and cross-examine opposing witnesses.

Interested persons may not cross examine witnesses, and will not be subject to cross examination. Interested persons may submit evidence (e.g., photographs, eye-witness testimony, monitoring data) if the evidence is submitted in accordance with the deadlines for submitting evidence described below. Interested persons who present evidence may be subject to cross-examination. Interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **18 April 2014**. The request must explain the basis for status as a designated party and in particular how the person is affected by the discharge.

The tentative Waste Discharge Requirements were issued on 19 March 2014. Persons wishing to comment on this item must submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than by 5:00 p.m. on **18 April 2014**. Written materials submitted after 5:00 p.m. on the above date will not be accepted and will not be incorporated into the administrative record absent a ruling by the Central Valley Water Board Chair. A party requesting to submit late materials must demonstrate good cause for the late submission, and the Central Valley Water Board Chair must find that the late submission would not prejudice the Central Valley Water Board or any designated party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Central Valley Water Board Chair. Both designated parties and interested persons may be asked to respond to clarifying questions from Central Valley Water Board members, counsel staff or others, at the discretion of the Central Valley Water Board.
