**NOTICE OF PUBLIC HEARING**  
concerning

**ADOPTION OF ORDER TO  
AMEND TIME SCHEDULE ORDER NO. R5-2011-0045  
FOR THE  
MODOC JOINT UNIFIED SCHOOL DISTRICT  
GEOTHERMAL PROJECT  
MODOC COUNTY**

On 10 June 2011, the Central Valley Regional Water Quality Control Board (Central Valley Water Board) adopted Waste Discharge Requirements (WDR) Order No. R5-2011-0044, NPDES Permit No. CA0082406, and Time Schedule Order (TSO) No. R5-2011-0045 for the Modoc Joint Unified School District (Discharger). The WDRs regulate discharge of waste geothermal fluid from the Modoc Joint Unified School District Geothermal Project to the North Fork Pit River, a water of the United States.

The WDRs contain effluent discharge limits for copper and instantaneous maximum pH. TSO No. R5-2011-0045 included a time schedule for compliance with the copper limits and an interim effluent copper limitation. The Central Valley Water Board will consider amending TSO No. R5-2011-0045 to extend the length of the compliance schedule for copper and grant the Discharger an interim limit and compliance schedule for pH.

A public hearing to address this matter will be held during the Central Valley Water Board meeting, which is scheduled for:

The designated parties for this hearing are as follows:

- Modoc Joint Unified School District

Designated parties but not interested persons will have these rights: to call and examine witnesses; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. Central Valley Water Board staff will prepare the administrative record, and may present evidence, make an oral presentation and cross-examine opposing witnesses.

Interested persons may not cross examine witnesses, and will not be subject to cross examination. Interested persons may submit evidence (e.g., photographs, eye-witness testimony, monitoring data) if the evidence is submitted in accordance with the deadlines for submitting evidence described below. Interested persons who present evidence may be

subject to cross-examination. Interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 pm on 6 November 2014**. The request must explain the basis for status as a designated party and in particular how the person is affected by the discharge.

The notification for the planned amendment of TSO No. 2011-0045 was issued on **6 October 2014**. Persons wishing to comment on this item must submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than **5:00 pm on 6 November 2014**. Written materials submitted after this date and time will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair. Both designated parties and interested persons may be asked to respond to clarifying questions from Board members, counsel staff or others, at the discretion of the Board.
