NOTICE OF PUBLIC HEARING

HANGTOWN CREEK WATER RECLAMATION FACILITY
EL DORADO COUNTY**

The City of Placerville is the owner and operator of the Hangtown Creek Water Reclamation Facility (Facility) a publicly owned treatment works located at 2300 Coolwater Creek Road, Placerville, California. The Facility provides sewerage service for the City of Placerville and a portion of El Dorado County and serves a population of approximately 10,000. Treated wastewater from the Facility is discharged to Hangtown Creek, which flows to Weber Creek, and is ultimately discharged to the South Fork of the American River, a water of the United States.

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2014-0015, adopted by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 7 February 2014. A Cease and Desist Order is proposed to provide additional time for the Discharger to comply with the final zinc effluent limits in WDR Order R5-2014-0015.

The designated parties for this hearing are as follows:

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 9 December 2014**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than **5:00 p.m. on 9 December 2014**. Written evidence or comments submitted after **5:00 p.m. on 9 December 2014** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
