### ***ADMINISTRATIVE CIVIL LIABILITY COMPLAINT R5-2015-0500, FOR HERITAGE RANCH LLC***

Enclosed is an Administrative Civil Liability Complaint (Complaint), issued pursuant to California Water Code section 13323. This Complaint alleges that Heritage Ranch LLC (hereafter "Heritage Ranch" or "Discharger") failed to submit a Report of Waste Discharge ("RoWD") as required under Water Code section 13260, and recommends an administrative civil liability pursuant to Water Code section 13261 in the amount of **fifty one thousand four hundred and eighty dollars (\$51,480)**.

This 13260 Directive-related ACL Complaint is among the first ILRP enforcement cases of this kind to be considered by the Central Valley Water Board. Because of the precedential nature of this case, Board staff will not attempt to negotiate a settlement with the Discharger, but rather will defer the case directly to the Board.

A hearing will be scheduled for the **16/17 April 2015** Board meeting in Fresno. This hearing will be governed by the attached Hearing Procedures, which have been approved by the Board Chair for use in adjudicating matters such as this one. Any objections to the Hearing Procedures must be received by Patrick Pulupa, whose contact information is listed in the Hearing Procedures, by **5 p.m. on 29 January 2015**.
