SACRAMENTO COUNTY

The Dellar Landfill is a 26-acre, partially-closed landfill on "A" Street immediately south of the American River and adjacent levee about 1½ mile northeast of downtown Sacramento. The landfill operated from 1957 through 1963, accepting primarily household wastes. The landfill is unlined and predates current Title 27 regulatory standards. Low concentrations of volatile organic compounds (VOCs) have been historically detected down gradient of the site, indicating a possible gas release from the landfill. In 2012, the Discharger closed (i.e., installed engineered soil cover over) over the majority of the landfill footprint. Additional landfill closure-related work was conducted in 2014. Less than one acre of the landfill remains to be closed, limited to areas where there are Elderberry bushes. The proposed Order prescribes requirements for completing closure of the remainder of the landfill consistent with interested agency approvals, and for conducting landfill postclosure maintenance and corrective action monitoring at the site.

Interested persons may not cross examine witnesses, and will not be subject to cross examination. Interested persons may submit evidence (e.g., photographs, eye-witness testimony, monitoring data) if the evidence is submitted in accordance with the deadlines for submitting evidence described below. Interested persons who present evidence may be subject to cross-examination. Interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than **30 March 2015**. The request must explain the basis for status as a designated party and in particular how the person is affected by the discharge.

Tentative waste discharge requirements for the facility were issued for public comment on **27 February 2015**. Persons wishing to comment on this item must submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than by 5:00 p.m. on **30 March 2015**. Written materials submitted after 5:00 p.m. on the above date will not be accepted and will not be incorporated into the administrative record absent a ruling by the Chair. A party requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that the late submission would not prejudice the Central Valley Water Board or any designated party.

All designated parties and interested persons may speak at the Regional Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair. Both designated parties and interested persons may be asked to respond to clarifying questions from Board members, counsel staff or others, at the discretion of the Board.
