Dear Mr. Redding:

My office represents Seneca Gold, LLC. If you are represented by an attorney, please forward my email to them and have them contact me.

It has come to my client's attention that you are attempting to preclude my client from obtaining a permit from the Water Board. You have also submitted an incorrect information that there is a dispute between the property owners and my client. This is incorrect since the case between the Preims and Seneca Gold, LLC has been settled and a court order to that effect has been signed by the judge.
