YOLO COUNTY**

The City of Woodland is the owner and operator of the City of Woodland, Water Pollution Control Facility (Facility), a publicly owned treatment works located at 42929 County Road 24, Woodland, California. The Facility provides sewerage services for the City of Woodland, serving a population of approximately 55,800. The Facility provides tertiary treatment for up to 10.4 million gallons per day. The treated wastewater from the Facility is discharged to Tule Canal.

Discharges from the Facility are currently regulated by Waste Discharge Requirements (WDR) Order R5-2014-0120 (NPDES Permit No. CA0077950), issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 9 October 2014. The Division of Drinking Water conducted a review of the ultraviolet light (UV) disinfection system at the Facility, and subsequently submitted specific UV system operational requirements to the Executive Officer of the Central Valley Water Board in a letter dated 25 June 2015. Therefore, the Central Valley Water Board will consider amending WDR Order R5-2014-0120 to update UV disinfection specifications.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 11 February 2016**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board, or via email to RB5S-NPDES-Comments@waterboards.ca.gov no later than **5:00 p.m. on**

11 February 2016. Written evidence or comments submitted after **5:00 p.m.** on **11 February 2016** will not be accepted and will not be incorporated into the administrative record absent a ruling by the Chair. Any party requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that accepting the late submission will not prejudice the Central Valley Water Board or any Designated Party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
