Processing is complete for the 2015 season, the only activity Williams will have until July 2016 is maintenance and shipping of product. As a tentative date for next production startup is early July 2016.

I have received another complaint in regards to Morning Star Company. Please see below.

Dear Kaljeet: You asked me to contact you when the odor from Morning Star was bad and this message is for the last few days.

- On the 21st, from midafternoon till about 9:00 p.m. Very bad, could not open windows.
- On the 25th, early evening till way after dark, Bad, but not overly strong.
- On the 27th, late afternoon till around 10:00 p.m. Horrible, had to run air conditioning most of the night because I could not open the windows. Also noticed an unusual amount of flies on the house and windows. Do not know if this is related, but the odor was overwhelming.

I hope you relay this information to the State, I have had enough of this. When you can't open your windows due to the smell, it is pretty bad.

Thank you for your help in this matter.

Could I please get a response with actions being taken to mediate the issue.
