The Kings River Water Quality Coalition (Coalition) has been approved by the Central Valley Regional Water Quality Control Board (Regional Board) to serve as a Third Party for administering the terms and conditions of the Irrigated Lands Regulatory Program, as described in the Tulare Lake Basin Waste Discharge Requirements General Order No. R5-2013-120 (the "General Order"). The Coalition has been formed to represent landowners and operators irrigating agricultural lands (Members) under the General Order.

The undersigned hereby elects to become a Member of the Coalition and acknowledges that Membership dues are charged to cover the costs of meeting the requirements of the General Order. The undersigned acknowledges that it is his/her responsibility to know and understand the terms and conditions pertaining to Members contained in the General Order, and that failure to comply with such terms and conditions may subject the Member to removal from the Coalition and/or enforcement action by the Regional Board.

Termination of membership in the Coalition will also be granted 10 days after Coalition receipt of a written notice of membership termination. Upon termination, the landowner/operator will be required to seek alternative coverage under the Irrigated Lands Regulatory Program.


